#### Mental Health Tribunal and Associate Hospital Manager panels returning to face-to-face hearings

Under a pilot scheme, from 3/10/22 (for non-s2 cases) and from 7/11/22 (for s2 cases) the patient will be asked to express a preference ("hearing by video", "hearing at the hospital" or "no preference"; in the last case the default will be video).

A face-to-face hearing preference must be communicated at least 14 days (for non-s2 cases) or 72 hours (for s2 cases) before the hearing. The intention is to meet the patient's preference when possible (subject to panel availability, lockdowns etc); an urgent application should be made if the patient changes his mind.

The responsible authority can also express a preference. Regional listing will resume, but national listing will be available for video hearings to meet demand. Legal representatives will be asked to complete a survey.

Associate Hospital Managers will also offer face to face hearings from November 2022.

#### Recording of event: Marking 20 years since 'Breaking the Circles of Fear' report by Centre for Mental Health

A webinar which took place on the 06 July, to mark 20 years since the publication of the landmark report 'Breaking the Circles of Fear'. This event was an important moment to review what has and has not changed since 2002, to set a renewed ambition for change in tackling systemic racism in mental health care and in wider society, and to honour people's lives and struggles.

# Case (Residence). K v N Council [2022] MHLO 1 (COP)

The court had to decide where K (who only spoke Polish) should reside: (a) her current culturally Polish care home, where all staff and residents could speak Polish; or (b) a care home proposed by her Polish family which was much closer to them, enabling regular visits, but at which Polish staff were only sometimes on duty. The "magnetic factor" was the need for K to be able to communicate freely 24/7, unhindered by any language barrier, so it was in her best interests to remain where she was. ### Case (Non-treatment of eating disorder). A Mental Health NHS Trust v BG [2022] EWCOP 26

The judge decided it was not in BG's best interests to receive further treatment for eating disorder, and she subsequently died. (2) It would not be proper for a decision for this gravity to be made in secret, so the blanket reporting restrictions order was discontinued and publication of some information was permitted. #### Annual DoLS statistics (England) released

NHS Digital has released the annual DoLS statistics for England, covering the period April 2021 to March 2022. The figures show an increase of 5.5% in applications following a drop during the covid-19 pandemic. The backlog of applications not assessed or completed has also risen to over 122.000.

#### **Independent Care Reviews**
